TEXAS SCHOOL FOR THE DEAF	Since TSD is a one-campus School and has no "neighboring school districts", on the request of a parent or other person with authority to act on behalf on the victim of the sexual assault, the Superintendent or designee may transfer the victim to another classroom, whether that assault occurred on or off campus, and that student has been convicted of or placed on deferred adjudication for that assault.				
	Additionally, with respect to providing educational services to the assailant, the School shall consider that the School is not intended to serve 1) students whose needs are appropriately addressed in a home or hospital setting or a residential treatment facility; or 2) students whose primary, ongoing needs are related to a severe or profound emotional, behavioral, or cognitive deficit.
